The course is an introduction to Artificial Intelligence. We will cover the fundamentals used in the construction of intelligent agents, including heuristic search for problem solving, computer games, probabilistic reasoning, Bayesian networks, machine learning including neural networks, ChatGPT (briefly if time allows), and so on.

5. Methods of Evaluation

- Three assignments, worth 5% each.
- All assignments are due by 11:55 pm of the due date, submitted via OWL. The due dates of the three assignments are: 2/6, 3/6, and 4/6
- Midterm: 35%, tentatively scheduled on 3/2 (Monday’s in-class midterm)
- Final Exam: 50% (covering the whole term)
- For both midterm and final exams, students can bring a one-page 8x11 “cheat sheet” (double-sided, written or printed). The exam will be closed book, with no access to any electronic devices. The exam is to be completed individually, with no assistance from others.
- Multiple mini Practice Sessions will be embedded in the lectures to help with the assignments, midterm and final exams.

Late Assignment Policy of assignments:

Each day (24 hours) is 10% off (e.g., if late for 2 days, 20% off), until 10 days have passed and

the assignment will be worth 0.

Students can use online resources (including AI models such as ChatGPT) in understanding and completing their assignments. However, they must NOT copy-paste answers directly from the online resources in answering their assignments. This would be considered as Scholastic offences (see later). As students can easily consult AI models in assignment questions, assignments will be marked less stringently as the exams.

All Academic Consideration requests must include supporting documentation; however, recognizing that formal documentation may not be available in some extenuating circumstances, the policy allows students to make one Academic Consideration request **without supporting documentation** in this course. However, the following assessments are excluded from this, and therefore always require formal supporting documentation:

- Midterm and Final Exams

That is, students may use the Academic Consideration without supporting documentation on one of the assignments, and if so, they receive a three-day extension automatically on that assignment. Such a request cannot be recalled and reapplied.

Evaluation Scheme for Missed Assessments

If you must miss the Midterm Exam for a valid reason, you must submit your absence request along with documentation through the SAP (Student Absence Portal) and then notify me.

prior to the Midterm Exam. A make-up Midterm will be arranged for these students.

When a student misses the Final Exam and their Academic Consideration has been granted, they will be allowed to write the Special Examination (the name given by the University to a makeup Final Exam). If for any reason the assignment schedule given below cannot be adhered to, the assignment marks will be prorated.
